



3rd Annual HALL OF FAME – May 15, 2010

CONSTITUTION AND BY-LAWS

The Lansdale Catholic High School Hall of Fame was created in 2007 to honor those individuals or groups whose actions or achievements in their chosen fields bring honor and distinction to the heritage of Lansdale Catholic High School.

Categories of Recognition

Achievement

Alumni of Lansdale Catholic High School whose distinguished actions have led to outstanding recognition in their chosen fields on a local, national, or international level.

Life Time Recognition

Alumni of Lansdale Catholic High School who shall be out of school for at least twenty-five (25) years and whose lives have reflected character and distinction.

Service

Alumni, faculty, staff, or friends of Lansdale Catholic High School whose actions and/or achievements may not be categorized otherwise, but are deserving of such recognition and honor.

Athletics

Alumni, faculty, and staff of Lansdale Catholic High School who have established outstanding records of achievement in their chosen sport which would make them deserving of such recognition and honor.

Criteria for Selection

To be eligible for selection an alumnus must have graduated from Lansdale Catholic High School at least ten (10) years prior to nomination and have attended at least two (2) years at Lansdale Catholic High School.

Members of the teaching faculty, with a minimum of ten (10) years service, or coaching staff with a minimum of two (2) years of service, may be nominated.

One posthumous selection may be made annually.

General criteria to be considered in the evaluation are as follows:

1. A graduate or staff member whose actions demonstrate outstanding character.
2. A graduate or staff member whose outstanding citizenship has achieved international, national, or local recognition.
3. A graduate or staff member whose leadership can inspire students in the pursuit of excellence.
4. A graduate or staff member whose accomplishments are outstanding or whose leadership is considered exceptional.

Once placed on the nomination list, the nominee will remain in consideration for five years, after which time, if not elected to membership his/her name shall be removed from the list. The individual can be nominated again.
